- 1. Learner's ID or birth certificate. Grade 12 learners MUST HAVE a legal South African ID or a student permit.
- 2. ID of person responsible for the account.
- 3. Report from previous school (Only new learners).
- 4. Grades may be done over 2 years.
- 5. Grade 12 first time learners must submit legal Grade 10 and 11 reports.
- 6. Grade 12 repeaters must submit the previous Grade 12 report/Umalusi certificate.
- 7. SACAI registration form First Timer OR Repeater.

IMPORTANT INFORMATION

- > Invoicing will be done within 7 working days after receiving the complete Registration form and all additional documents.
- > Fees will be calculated Pro-rata if a learner joins later during the year and a R500 administration fee will be charged.
- > All cancellations carry a R500.00 administration fee.
- > **Textbooks** are **NOT INCLUDED** in the Auxilio fee. Textbook lists available on the Auxilio Website.
- All bank charges on cash deposits will be invoiced to the client.
- > SBAs will be released on the dates provided on the year plan. For late fees, SBAs will be released within 7 working days from date of payment.
- ➤ Gr 10 11: Fees payable according to the payment arrangement and to be settled by 3 October 2024.
- > Gr 12: If fees are not settled by 3 July 2024 the learner will be deregistered for the NSC exam.
- > If a refund is applicable after cancellation, it will be paid within 30 days from receipt of written cancellation.
- ➤ Hospitality Studies PAT If learner makes use of their own qualified Assessor this would be for their own account, **OR** the Auxilio Assessor at R 1 100.00 via Zoom session if it is still an accepted method by Umalusi in 2024.
- ➤ Consumer Studies PAT If learner makes use of their own qualified Assessor this would be for their own account, **OR** the Auxilio Assessor at R 825.00 via Zoom session if it is still an accepted method by Umalusi in 2024.

- > SACAI registration is compulsory.
