1. Learner's ID or birth certificate. **Grade 12 learners MUST HAVE a legal South African ID or a student permit.**
2. ID of person responsible for the account.
3. Report from previous school (Only new learners).
4. All grades may be done over 2 years.
5. Grade 12 first time learners must submit **legal Grade 10 AND 11** reports.
6. Grade 12 **repeaters** must submit the **previous Grade 12 report/Umalusi certificate.**

### IMPORTANT INFORMATION

- Invoicing will be done within 7 working days after receiving the complete Registration form and all additional documents.
- Fees will be calculated Pro-rata if a learner joins later during the year and a R500 administration fee will be charged.
- All cancellations carry a R500.00 administration fee.
- **Textbooks** are **NOT INCLUDED** in the Auxilio fee. Textbook lists are available on the Auxilio Website & Platform.
- All bank charges on cash deposits will be invoiced to the client.
- SBAs will be released on the dates provided on the year plan. For late fees, SBAs will be released within 7 working days from date of payment.
- Gr 10 – 11: Fees payable according to the payment arrangement and to be settled by 3 October 2025.
- Gr 12: If fees are not settled by 3 July 2025 the learner will be deregistered for the final NSC exam.
- If a refund is applicable after cancellation, it will be paid within 30 days from receipt of written cancellation.
- Hospitality Studies PAT – If learner makes use of their own qualified Assessor this would be for their own account, **OR** the Auxilio Assessor at R 1 135.00 via Zoom session if it is still an accepted method by Umalusi in 2025.
- Consumer Studies PAT – If learner makes use of their own qualified Assessor this would be for their own account, **OR** the Auxilio Assessor at R 850.00 via Zoom session if it is still an accepted method by Umalusi in 2025.
- Gr 12 NSC CAT Practical Exam - An additional fee may be charged by the Examination centre. This is for the parent's account.
- Should a Gr 12 Repeater student wish to NOT redo their SBA, contact Auxilio directly for fees.
- SACAI registration is compulsory.
- All SACAI fees will be invoiced by Auxilio cc, and are payable to Auxilio cc, no direct payments may be made to SACAI.
- The learner will not be registered with SACAI and therefore not be eligible for the NSC exam if the SACAI fee is not paid as per the agreement.
